In the event these documents do not meet the accuracy guidelines acceptable by the Authority, the alternate method of admeasurement set forth in the "Regulations for the Admeasurement of Vessels to Assess Tolls for the Use of the Panama Canal" will be applied.</p> <p>4. The ballast conditions means without passenger or cargo. Empty containers are considered cargo.</p> <p>5.
