This additional slot is subject to the same requirements as the normal booking slots.</p> <p>(2) The cancellation charge for an awarded auctioned slot shall be 90% of the winning bid.</p> <p>(3) Vessels awarded the auctioned slot have the same options as those with conventional booking slots, such as requesting same-day transit due to late arrival, swaps and substitutions, except change-in-transit date. The late arrival fee for vessels awarded a booking slot via the auction process, will be the corresponding percentage of the reservation fee based on the vessel dimensions and not on the percentage of the auction amount.</p> <p>(4) An auction slot awarded to a fully integrated barge shall be assigned to the larger craft; the booking of the smaller craft shall be computed based on the normal transit reservation tariffs.</p>
